The passing of the Health Information Technology for Economic and Clinical Health Act (**HITECH**) mandated additional guidelines for the Health Insurance Portability and Accountability Act (**HIPAA**). **All Long-Term Care facilities are required to comply.**

Enforcement is scheduled to begin NOW!

The provisions call for **STIFFER PENALTIES:**

- For **PRIVACY AND SECURITY VIOLATIONS**
- For changes to breach notification and accounting for disclosures requirements
- Extended HIPAA security provisions to business associates.

This seminar is also a "**REFRESHER COURSE**" and **REVIEW** of basic HIPAA REQUIREMENTS (as updated by HITECH).
